## **Objectives and Investment Policy**

#### Objective

The Fund aims to maximize middle to long-term growth through investment in Japan.

#### **Investment Policy**

The Fund is actively managed and invests primarily in listed equities and/or equity related securities of companies domiciled in Japan or companies with predominant commercial activities in Japan based on bottom-up research.

The performance of the Fund is measured against the Russell Nomura Small Cap Total Return Index (the "Index"). The Fund will invest primarily in the constituents of the Index, however investments will not be limited to the constituents of the Index.

#### Accumulation

Any income arising from the Fund will be accumulated and reinvested

Historical data, such as is used in calculating the synthetic indicator, may not be a reliable indication of the future risk profile of the Fund. This indicator is an expected measure of the Fund's volatility. The higher a fund's past volatility the higher the number on the scale and the greater the risk that investors in that fund may have made losses as well as gains. The lowest number on the scale does not mean that a fund is risk free. The Fund has been classed as a Category 6 as this category best describes the volatility level of the Fund.

The Fund has a high risk rating because it invests in equities the value of which can move up and down over time to a greater extent than some other investments. Additional specific risks of investing in the Fund include:

#### **Currency risk**

Investing in assets in a currency other than your own currency exposes

#### Dealing

You may redeem your shares in the Fund on each business day, which is any day (other than Saturday and Sunday) on which banks are generally open for business in Ireland, the United Kingdom and Japan.

#### **Other Information**

This class uses currency hedging. Please see the section 'Hedged Classes' in the Fund's supplement.

The Investment Manager recommends 3-5 years investment in the Fund.

#### **Concentration risk**

The Fund may hold a limited number of investments or may hold concentrated positions, leading to a lack of diversification. If a single investment falls in value it can have a greater impact on the Fund's value than if it held a larger number of investments or more positions.

#### **Country risk**

The Fund invests with a single country focus which will increase the risk of investing over a Fund that invests in a globally diversified range of countries.

#### **Operational risk**

This includes risks relating to the safekeeping of assets. The depositary who holds the Fund's assets is subject to independent external audit and is supervised by regulators.

#### **Hedging risk**

The shares will undertake hedging transactions such as forward currency contracts, with the intention of mitigating shareholders' exposure to movements in the base currency of the Fund. Whilst this is intended to substantially protect investors against a fluctuation in the value of the base currency of the Fund against the relevant share's class currency, this will not provide total protection against currency fluctuations and may lead to variations in the NAV per share and thus the relative performance of a share class.


