# What is this product?

### Type

This product is a UCITS.

The fund has no termination date. However the Management Company may, at its discretion, decide to terminate or merge the fund or its unit series.

### Objectives

Storebrand Global ESG Plus aims to invest in companies with strong sustainability ratings, and at the same time mimic the risk and return profile of the global equity market.

The fund is a fossil-free and index-tracking global equity fund that invests widely in various industries in developed markets. The selection of companies is optimized based on Storebrand's sustainability assessment model. According to this model, companies are assigned grades based on how well they are positioned for global trends, sustainable operations and financial stability. The fund complies with Storebrand's sustainable investment standard, which means, for example, that it refrains from investing in companies that violate international laws and regulations, human rights or workers' rights, are involved in corruption, serious climate or environmental damage, controversial weapons (land mines, cluster and nuclear weapons) or tobacco or that score low on sustainability.

The fund also refrains from investing in companies that have more than 5 per cent of their revenues from: fossil fuels, weapons/war materials, tobacco, alcohol, gambling or pornography or companies with large fossil sources.

Dividends and other income will be reinvested in the fund.

Derivatives may be used to ensure less expensive or more efficient management.

#### Intended retail investor

The fund offers a diversified portfolio of securities for investors interested in wealth accumulation, pension savings or similar investment purposes.

The recommended holding period of the fund is at least 5 years assuming the fund is the sole or major holding of the investor. The recommended holding period is primarily based on the historical volatility of the underlying investments and is not directly applicable if used in a portfolio based on the investor's risk profile. The fund is not intended for short term speculation purposes.

The fund is intended for investors who accept and understand that the value of the fund is directly linked to the value of underlying investments, will fluctuate over time and that the invested amount can be lost entirely or partly. Investments in the fund require no specific knowledge of the financial market or instruments from the investor.

# What happens if Storebrand Asset Management AS is unable to pay out?

# What are the costs?
