What is this product?

Type

This product is a UCITS.

The fund has no termination date. However the Management Company may, at its discretion, decide to terminate or merge the fund or its unit series.

Objectives

Storebrand Global Solutions is a fossil-free equity fund that aims to achieve a long-term excess return by investing in global equity markets, including emerging markets.

The fund invests in sustainable companies that we believe are well positioned to solve the challenges related to the UN's sustainability goals. The fund is subject to additional criteria beyond the Storebrand standard, which means that it refrains from investing in companies that have more than 5 per cent of their revenues from: fossil fuels, weapons/war materials, tobacco, alcohol, gambling or pornography or companies with large fossil sources.

Dividends and other income will be reinvested in the fund.

Derivatives may be used to ensure less expensive or more efficient management. For more information, see the fund's prospectus.

Intended retail investor

The fund offers a diversified portfolio of securities for investors interested in wealth accumulation, pension savings or similar investment purposes.

The recommended holding period of the fund is at least 5 years assuming the fund is the sole or major holding of the investor. The recommended holding period is primarily based on the historical volatility of the underlying investments and is not directly applicable if used in a portfolio based on the investor's risk profile. The fund is not intended for short term speculation purposes.

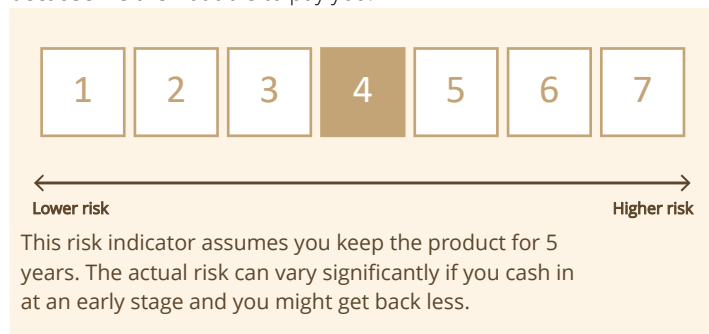

What are the risks and what could I get in return?

Risk Indicator

What happens if Storebrand Asset Management AS is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary. In the event of our insolvency, the Fund's assets in the safekeeping of the depositary will not be affected. However, in the event of the insolvency of the depositary, or someone acting on its behalf, the Fund may suffer a financial loss. This loss will not be covered by any investor compensation or a guarantee scheme. However, this risk is mitigated to a certain extent by the fact that the depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure to properly fulfil its obligations (subject to certain limitations).

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. - In the first year, you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
