# What is this product?

### Туре

This product is a UCITS sub-fund of Brown Advisory Funds Plc. The Fund's assets are held through its Depository, which is Brown Brothers Harriman Trustee Services (Ireland) Limited.

### **Investment Objective**

The Fund aims to achieve capital growth.

### **Investment Policy**

At least 80% of the Fund will be invested in US equities. The Fund invests in small-sized companies - both undervalued companies and growth companies - listed or traded on US markets and exchanges, generally whose total market values are equal to or less than USD 6 billion at the time of initial investment. The Fund may also invest in US Rule 144A Securities, American Depositary Receipts, US treasury bills, fixed and/or floating rate US government securities and other ancillary liquid assets. This class utilises forward foreign exchange contracts (an obligation to purchase or sell a foreign currency at a specific date and exchange rate) to hedge currency risk between the share class currency and the US dollar.

## Benchmark

The Fund uses the Russell 2000 index as a Comparator Benchmark to compare performance. The Fund is actively managed and is not constrained by any benchmark.

## **Dealing Frequency**

Investors may redeem shares on demand on any day (except Saturday or Sunday) on which the New York Stock Exchange is open.

### **Distribution Policy**

The Fund does not intend to distribute income on your shares. The price of your shares shall rise by the net income earned per share.

#### Intended Investor



## Risk Indicator

# What happens if Brown Advisory is unable to pay out?
