What is this product?

Type

This product is a UCITS sub-fund of Brown Advisory Funds Plc. The Fund's assets are held through its Depository, which is Brown Brothers Harriman Trustee Services (Ireland) Limited.

Investment Objective

The Fund aims to achieve capital growth.

Investment Policy

At least 80% of the Fund will be invested in equity securities. The Fund invests in mid-size and large companies generally with market capitalisations above \$2billion at the time of purchase that the Investment Manager believes have strong, or improving, long-term business characteristics and share prices that do not reflect these favourable fundamental attributes and which are listed or traded on US markets and exchanges. The Fund may also invest in: nonUS securities; convertible debt securities including US Rule 144a Securities; American and Global Depositary Receipts; US treasury bills; fixed and/or floating rate US government securities; real estate investment trusts and unlisted securities.

Benchmark

The Fund uses the S&P 500 index as a Comparator Benchmark to compare performance. The Fund is actively managed and is not constrained by any benchmark.

Dealing Frequency

Investors may redeem shares on demand on any day (except Saturday or Sunday) on which the New York Stock Exchange is open.

Distribution Policy

The Fund does not intend to distribute income on your shares. The price of your shares shall rise by the net income earned per share.

Intended Investor



Risk Indicator
